

Level 1 Coffee Collective Promotion Terms and Conditions

Information on how to enter and prizes form part of these conditions. By participating, entrants agree to be bound by these conditions. Entries must comply with these conditions to be valid.

- Who can enter?** Entry is open to current full Wests members who are 18 years of age or older. Employees and their immediate families of the Promoter, its agencies and venues associated with this promotion are ineligible to enter. This promotion is limited to Venues in New South Wales that have been invited by the Promoter to participate ("Participating Venue"). Participating venues are located on Wests New Lambton Level 1 dining precinct and include Chophouse Grill, Lure Restaurant, Emerald Gardens and Chocolate Café. Promotion not run at Wests Mayfield, Wests City, Wests Cardiff or Wests Nelson Bay.
